Funding Support for Singapore Citizen (SC) Students – An Illustration

Information on Subsidy

Students eligible for subsidy	Income criteria	How to Apply for Subsidy
Students under MOE FAS	Gross Household Income ("GHI") is \$3,000 or less, or Per Capita Income ("PCI")* is \$750 or less	No action required. Automatically subsidised for the PLD.
Students under School-based FAS or Independent Schools Bursary (ISB)	GHI is \$4,400 or less, or PCI is \$1,100 or less	Approach the school's General Office to apply for a subsidy.
Students who are currently <u>not</u> under the MOE FAS / School-based FAS / ISB	GHI is \$4,400 or less, or PCI is \$1,100 or less	Approach the school's General Office to apply for a subsidy.

Support Structure	What it is
Device Management Application (DMA)	 1 parent's personal email address will be provisioned with the DMA parent's account for viewing of your child's PLD info. "White-listed" (allowable) and "Black-listed" (blocked) websites
School Rules, Classroom Management and Routines	See Student Handbook pp. 12, 15 to 17
Educating Students on Cyber Wellness	Greater emphasis on the importance of digital literacy and cyber- wellness
Student Leaders as Peer Advocates	Training and guiding the Student Leaders as peer advocates for the responsible use of PLDs. These student leaders will strive to role model and positively influence their peers.
Partnering Parents/Guardians to support students' use of technology for learning	Engagement Workshops for Parents on partnering and guiding their child on the use of PLD.
Provision of Lockers	Safekeeping of PLDs if students are not using.

Technical Support for Students' PLDs

Technical support will be provided to students through :

• School-based Support

- ✓ Trouble-shooting of device issues
- \checkmark Solve connectivity issues
- ✓ Collection of devices to be sent for repairs (loan device to be provided by the school during downtime)
- Distributor's Direct Support (at designated service centres)
 - ✓ Repair/Replacement of devices (hardware issues)
