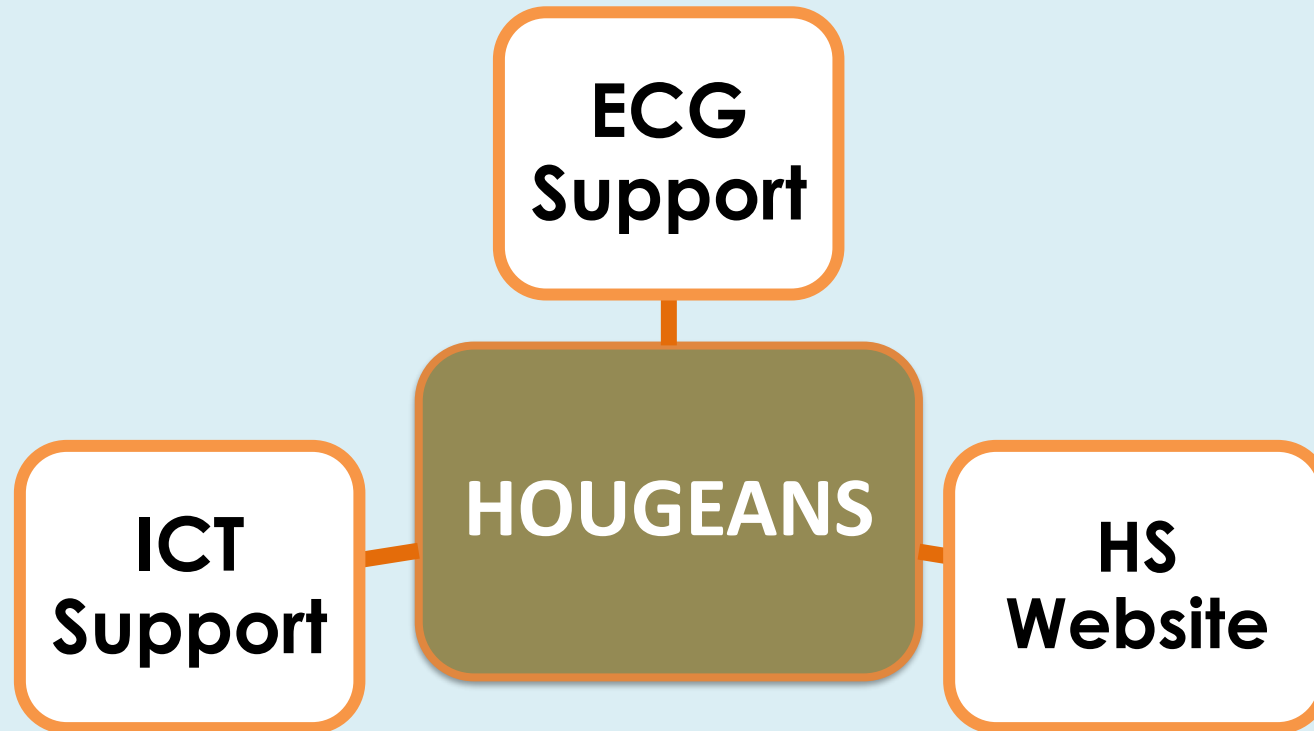

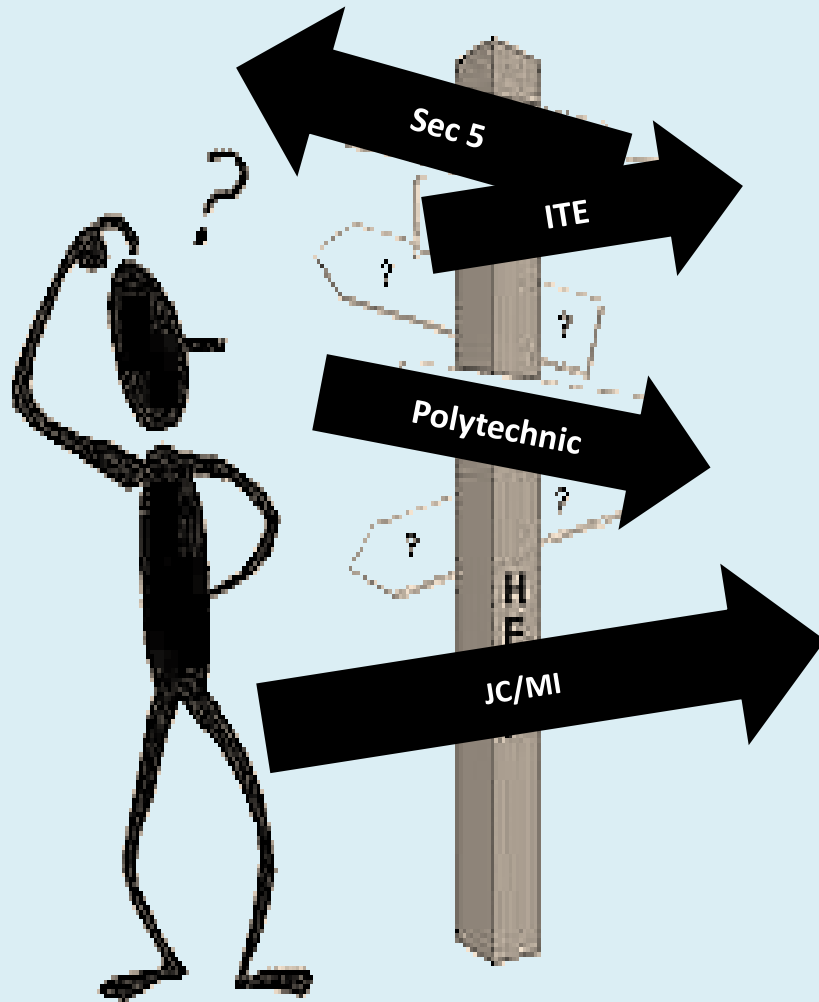

# KEY JAE Information

Applicants can **access JAE-IS with your SingPass or JAE PIN**. Your **JAE PIN** can be found in **Form A**.

School candidates will receive a digital copy of **Form A** via their registered email addresses from **2.00pm on Thursday, 11 January 2024**.

**Form A** will list the applicant's gross aggregate scores for JC, MI, polytechnic, ITE aggregate types and courses which he/she is eligible to apply for under the JAE.

The JAE-IS will be accessible from **4.00pm on Thursday, 11 January 2024, to 4.00pm on Tuesday, 16 January 2024** for applicants to submit their course choices through the JAE website at [www.moe.gov.sg/jae](http://www.moe.gov.sg/jae)

# KEY JAE Information

- All students **successfully admitted** to a school through **Direct School Admission-JC (DSA-JC)** / **Polytechnic Early Admissions (Poly EAE)** / **ITE Early Admissions (ITE EAE)** **will not be able to participate in the JAE.**
- **Successful DSA-JC and Poly EAE** students will receive their **Form A** that **indicate the school they are admitted to**
- **Successful ITE EAE** students will be **informed by ITE.**
- All students will **report to the institution** on the **same day** as **those taking part in the JAE**



# Eligibility for JC / MI Admission

- To be eligible for admission to JC/MI, students must **satisfy the admission criteria** to JC and MI.
- The Aggregate Type for **JC Course is L1R5** and **MI Course is L1R4**. The **aggregate score computation** for L1R5 and L1R4 is based on the **aggregate computation table**.
- Students who have **met the entry requirements** for admission to JC/MI will be **eligible to register** for JC/MI courses during the JAE registration period.



# Eligibility for Poly Admission

- To be eligible for Polytechnic courses, students must meet the following requirements:
  - a. Meet the entry requirements for admission to Polytechnic (i.e. <sup>1</sup>**26 points**<sub>1</sub> or better for the net <sup>2</sup>**ELR2B2** aggregate score<sub>2</sub>)

and

- b. Meet the **minimum entry requirement (MER)** for the Polytechnic course (i.e. **minimum subject grades**).





# Eligibility for ITE Admission

- GCE 'O' Level graduates can apply for Nitec courses under the January 2024 Intake exercise and the full-time April 2024 Higher Nitec courses under the MOE's Joint Admissions Exercise (JAE).
- ITE will provide a personalised **Form J** for each graduate. **Form J** will show the list of Nitec courses a graduate is eligible to apply for based on his/her GCE 'O' Level examination results.



# Eligibility for ITE Admission

- To be eligible for admission to *Higher Nitec* course, students must meet the following requirements:
  - a. Sit for the GCE 'O' Level subjects shown in the ELB4, ELR1B3 & ELR2B2 ITE Courses Tableand
  - b. Meet the **minimum entry requirements (MER)** for the *Higher Nitec* course (i.e. minimum subject grades).

Details of the courses' MER can be found in the JIE 'O' Level Admission Booklet.





# JAE 2024 Registration

- Students are advised to **consider all their 12 course choices wisely**. Students should refer to the **important points to note** for registration of courses **before they make their course choices**.
- **Beyond academic requirements**, students are advised that **some courses** may require students to **meet non-academic requirements**, such as passing of medical examinations, in order to **comply with industry requirements**. These requirements can be found in the **JAE information booklet** and students are advised to **take these requirements into account** when making their choices.





# JAE 2024 Registration

- The **L1R5 net aggregate** and **ELR2B2 net aggregates** of the lowest ranked students who were admitted to the JC and polytechnic courses respectively through the **2023 JAE** are meant to **serve only as a guide and do not constitute the admission scores for subsequent admission exercises.**



# JAE 2024 Registration

- Applicant should indicate **at least 2-3 courses where your aggregate scores (net) are much better than the previous year's course cut-off points (COP)**, to stand a **better chance for admission**.
- It is **not advisable** for a student to **only make a few course choices** because if he/she is **unsuccessful in getting a place** in any of his/her registered choices, he/she will be **posted to a course with remaining vacancies** after all the other students are being posted according to their registered choices.





# JAE 2024 Posting

- At the end of the JAE registration, posting will commence and students will **be posted to a course based on merit** according to their **net aggregate scores**.
- A student with a **better net aggregate score** will be **considered for admission first**, subject to the availability of vacancies in the selected course. If there are **no vacancies**, then the student **will be considered** for his/her **next choice course**.





# Appeal and Transfer after JAE POSTING release

- Students who wish to **appeal for a transfer to a JC** may **submit their appeals to JCs directly**, though they would **likely be unsuccessful if they have not met the course cut-off point for that year's JAE** and **do not present extenuating circumstances to merit a transfer**. **Eligible appeals** will be given **due consideration**, subject to available vacancies and school's admission criteria.
- Students who wish to **appeal for a place in a Polytechnic or ITE Higher Nitec course** may do so **online** through the combined Polytechnic and ITE *Higher Nitec* appeals portal at <https://jaeappeal.edu.sg> **within 4 working days** upon the **official release of the JAE posting results**.



# Appeal and Transfer after JAE POSTING release

- Students who were **not posted to any course during the JAE** are encouraged to **submit an appeal through the portal**. Results of the appeal will be **released through this portal**.
- At the end of the combined appeals period, all students who **had not received any Polytechnic or ITE Higher Nitec posting to a course of their choice** during the JAE Posting or JAE Appeals **will be offered a place in an alternative Polytechnic or ITE course**. Offers will be given based on **students meeting the minimum entry requirements and aggregate score of the lowest ranked students** who were admitted to these courses.
- This offer **is intended to provide students an additional option** for post-secondary education. Students who wish to appeal for a transfer to another course or institution **should approach the institution directly**.

## Dates

### Posted to JC/MI

- **You must report to the JC or MI on Friday, 2 February 2024.** You may wear your secondary school uniform and bring your original identification documents (NRIC, student pass or passport) when you report.
- If you are unable to report to your posted JC or MI on the first day of school due to valid reasons, you may contact your posted school directly to confirm that you are taking up the place, and the school will be able to reserve the place for you.
- If you are **waiting for an appeal outcome**, you should **still report to the school you are posted to**. You should **inform your posted JC or MI if your appeal is successful**.

### Direct School Admission – JCs

Students who had accepted offers through the **2023 Direct School Admission – Junior Colleges (DSA-JC)** will be admitted to their chosen JC if they have met the eligibility criteria for admission based on their GCE O-Level examination results. **Students admitted to a JC through DSA-JC will not be eligible to participate in the JAE.**

Students who do not meet the JC admission criteria may take part in the JAE to apply for other courses which they are eligible for.

<p><b>Early Admissions Exercise – Polytechnics</b></p>	<p>Students who had earlier accepted conditional offers to a polytechnic course through the <b>Polytechnic Early Admissions Exercise (EAE) in 2023</b> will have their offers confirmed and will not be eligible to participate in the JAE, if they meet the following criteria:</p> <ul style="list-style-type: none"> <li><b>a. A net ELR2B2 score of 26 points or better for the GCE O-Level examinations; and</b></li> <li><b>b. Minimum Entry Requirements for the respective polytechnic courses.</b></li> </ul> <p>Students who do not meet the above criteria will still get another chance to apply to polytechnic via the JAE.</p>

## Information

### Early Admissions Exercise – ITE

Students who had accepted conditional offers to an ITE course through the **ITE EAE in 2023** and have their offers confirmed based on their GCE O-Level examination results will not be eligible to participate in the JAE.

Their EAE offers are confirmed if they meet the subject-specific Minimum Entry Requirements for the course. More details on ITE EAE can be found at

<p><b>Progression Pathways for Secondary Four Normal (Academic) Students</b></p>	<p>Secondary 4 Normal (Academic) [N(A)] students who sat for O-Level subjects in 2023 can use their O-Level results for these subjects to apply for a place in the Polytechnic Foundation Programme (PFP) and Direct-Entry-Scheme to Polytechnic Programme (DPP).</p>



## Key Events

### Polytechnic Foundation Programme (PFP)

## Dates

The PFP is an alternative to the Secondary 5 N(A) year. It is a one-year foundation programme at the polytechnics that offers a practice-oriented approach to prepare students for entry into the relevant diploma courses.

Students are eligible to apply for the PFP if they obtain a **raw ELMAB3 aggregate of 12 points or lower; and meet the subject-specific requirements for their chosen course.**

PFP-eligible students who had taken O-Level subjects will receive a copy of **Form P** from their respective secondary schools when they collect their GCE O-Level results. **Each copy of Form P contains a unique password.** Interested students should use the respective passwords to submit their applications online via the PFP website at

More information on the eligibility requirements for the PFP, as well as how O-Level results are considered in the computation of the ELMAB3 aggregate, can be found on the PFP website.

Applications for the PFP will be open from **2pm on Thursday, 11 January 2024, to 4.00pm at 2pm on Tuesday, 16 January 2024.** The PFP posting results will be released at **2pm on Tuesday, 23 January 2024** through the PFP website. Students will thereafter be required to indicate whether they wish to accept, reject, or appeal for a change of course by **4pm on Friday, 26 January 2024.**

## Dates

### Direct-Entry-Scheme to Polytechnic Programme (DPP)

The DPP prepares students for progression into selected polytechnic diploma courses via a two-year *Higher Nitec* course at ITE. Students are eligible to apply if they obtain a raw ELMAB3 aggregate of 19 points or lower, and meet the subject-specific requirements for their chosen course.

Eligible Secondary 4 N(A) students may submit their DPP applications online via the DPP application portal at [www.ite.edu.sg/apply-for-ite-courses](http://www.ite.edu.sg/apply-for-ite-courses). Applications for the DPP will open from **2pm on Thursday, 11 January 2024**, to **11.59pm on Tuesday, 16 January 2024**.

The DPP posting results for applications made under the final application phase will be released at **9am on Thursday, 18 January 2024** through the DPP application portal. Students will be required to indicate whether they wish to accept or reject the DPP offer by **11.59pm on Monday, 22 January 2024**.

### For successful PFP and/or DPP applicants

Students who have been offered a place in the DPP under the final application phase should report to ITE on **Monday, 22 January 2024** upon acceptance of their DPP course offer.

The last day of school for Secondary 5 students who have accepted a place in the PFP will be on **Friday, 26 January 2024**. Students will be informed by the respective polytechnics on the enrolment dates for the PFP.

Students who have accepted a place in the earlier application phase of the DPP in December but decide to take up a PFP offer now must withdraw from the DPP first before they are able to take up the PFP offer. DPP-enrolled students should check with their ITE class advisor for more details on the DPP withdrawal process and deadlines for withdrawal.

# Administrative Instructions

Actions to take for any amendment to the CCA Certificate or Testimonial Draft

- STILL acknowledge the RECEIPT
- Clearly indicate the error and bring the edited copy to the General Office after release of results (4 pm onwards)
- Ask for a duplicate copy to facilitate your applications before you leave GO



# Certificate Amendment Request

- Candidates may request for a re-print of their current exam year certificate only if their name has been printed wrongly due to misspelling.
- There is an administrative fee of S\$50.00 (inclusive of GST) for the amendment of each GCE O-Level certificate.
- Request must be submitted to the school by **Wednesday, 17 January 2024**. Each request will be reviewed and is subject to approval.





# Appeal for Review of Results

- Candidates can request for an appeal to review their results. This comprises a **review of the marking and a full clerical re-check**. The candidate will be informed of the outcome via a letter. **No report on the candidate's performance will be provided.**
- The deadline for the application for appeal of results and the payment of appeal fees is **17 January 2024**.
- Please note that no further application will be considered after the appeal deadline.
- All appeals must be submitted through the school.
- A fee will be charged for an appeal to review the result for each subject.

## E.g. Individual Appeal

- The fee is S\$114.45 per subject (inclusive of GST).
- The outcome of the Appeal is expected to be released to schools by 27 February 2024.



# Applications Procedure for Repeat students

- Eligible students who wish to repeat Sec 4E or Sec 5N(A) should complete the application form from the General Office and submit it to the school in either of the time periods shown below:

## (a) First period

- By the 5th working day from the date of release of the GCE O-Level Examination results. **The first working day** is taken to be the **day after the release** of the GCE O-Level Examination results; or

## (b) Second period

- By the 5th working day, from the date of release of the Joint Admissions Exercise (JAE) posting results. **The first working day** is taken to be the **day after the release** of the JAE posting results.
